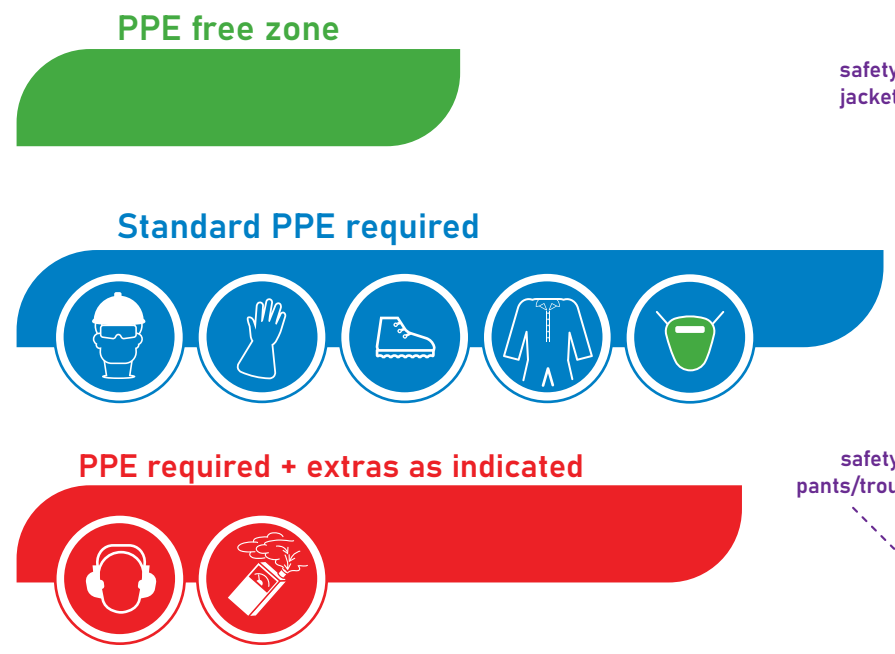


DONT'S

- Smoking and open fire are strictly prohibited on the entire site. Smoking is only permitted in the specially designated areas.
- Eating and drinking in the workplace outside, in laboratories and installations is prohibited.
- Film/Photography is not allowed without a valid permit.
- Entering the installations without the permission of the shift supervisor is prohibited.
- Wearing rings is prohibited in the production environment of Nouryon.

In case of emergency

In case of emergency and / or accident report:

- Who you are
- What happened
- Where it happened

What to do when the alarm goes off

- Stop all work, switch off equipment and ventilation systems.
- Close windows and doors (not locked).
- Leave the workplace in cross wind direction to the nearest assembly point (Safety Area).

Test alarm: Every Monday at 12:00

DO'S

- Cleanliness, order and hygiene (good housekeeping).
- Always hold the handrail when using stairs.
- The national road traffic regulations apply to the site area. The maximum speed is 20 km/h.
- Visitors are always accompanied.



Life Saving Rules

Stop working when you see unsafe conditions or behavior.

- Work with a valid work permit when required.
- Make sure moving machinery is guarded.
- Wear a seatbelt in motor vehicles when provided.
- Use fall protection when working at height.
- Check equipment is isolated before work begins.
- Do not use alcohol or drugs at work.
- Obtain a permit for entry into a confined space.
- Obtain authorization before disabling safety equipment.

If you break one of these "Life Saving Rules", a life-threatening situation can arise. Therefore, appropriate sanctions will follow in case of any violations.

First aid and accidents

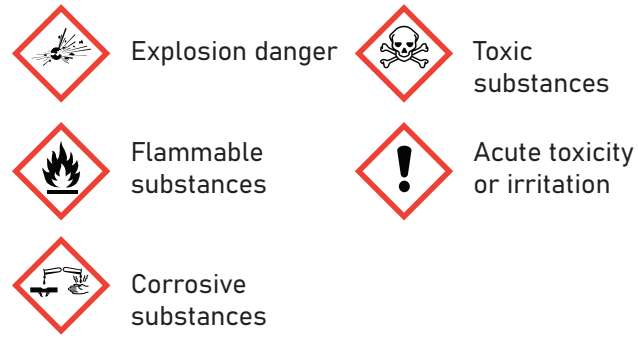
Any injury must be treated by a first-aider or at the medical post. Any accident should be reported to the shift supervisor.

Avoid any contact with hazardous substances!

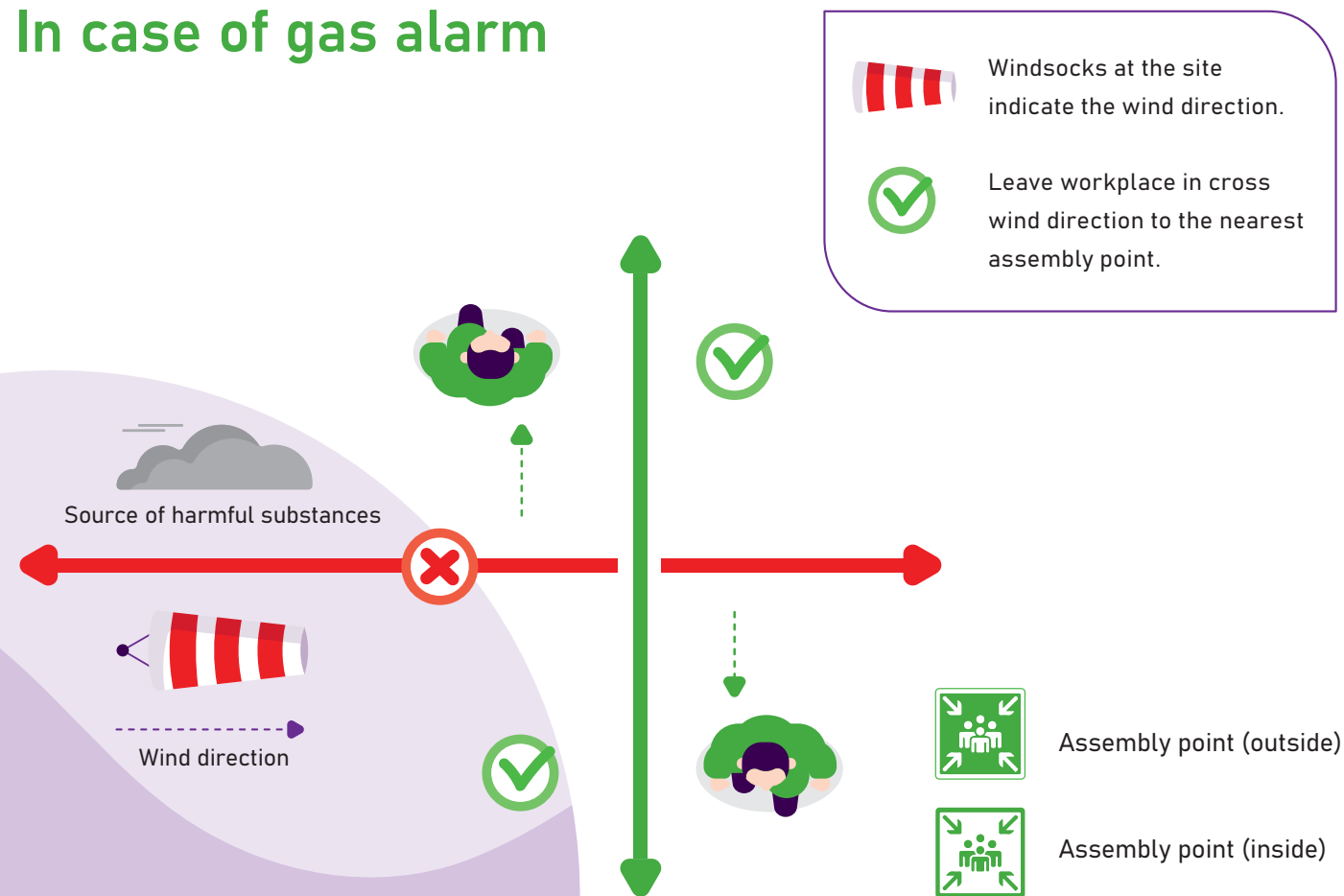


EX Potentially explosive areas are marked with yellow-black markings and this sign.

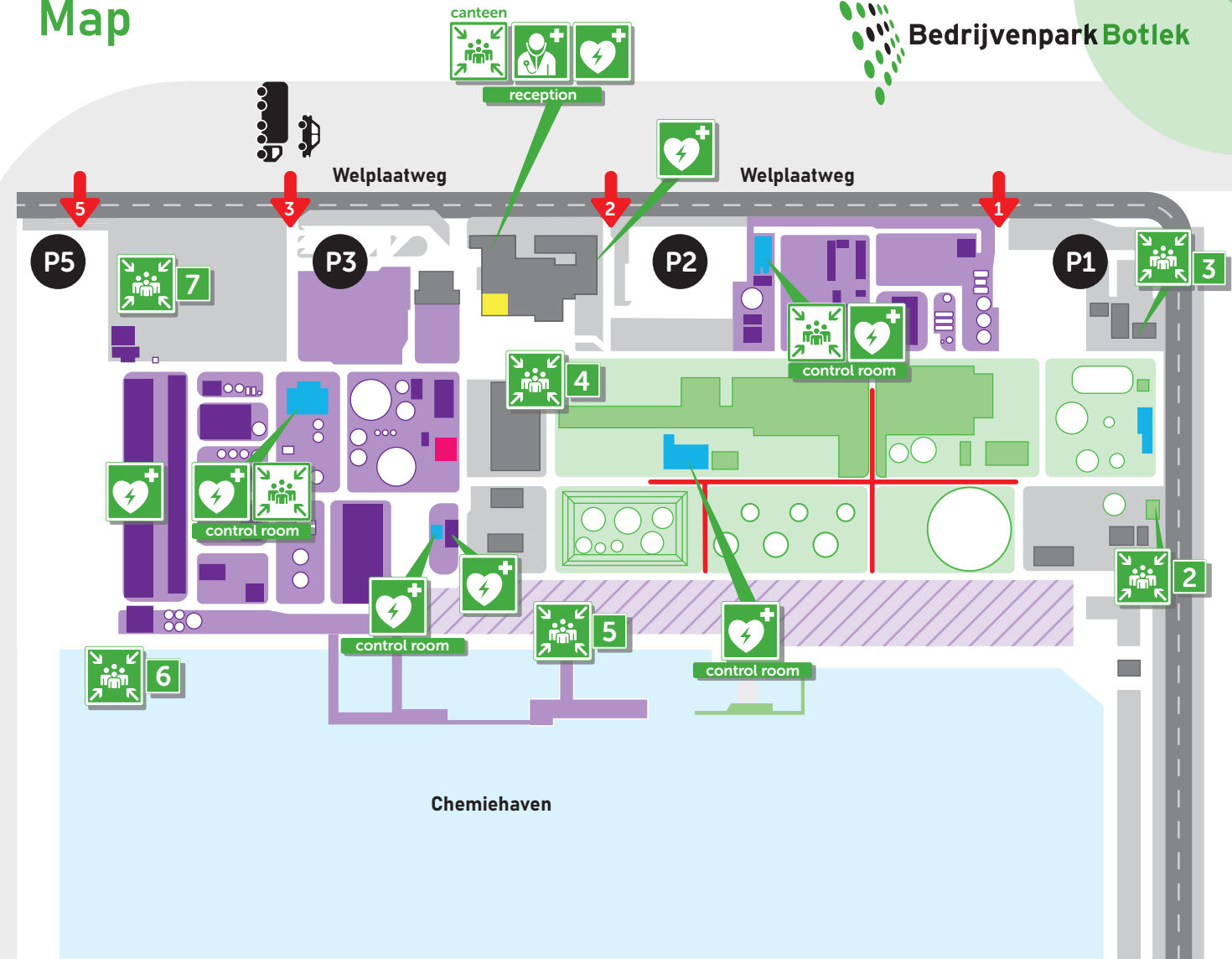


Immediately report use of a fire extinguisher to the shift supervisor.
